To ensure smooth operation during New Year and Tet Holiday 2025, Tan Cang Hai Phong International Container Terminal (TC-HICT) hereby advises our operational plan as follows:

1. Holiday schedule

- New Year 2026: 04 (four) days from Thursday, January 1^{st} , 2026 to Sunday, January 4^{th} , 2026.
- Lunar New Year: 09 (nine) days from Saturday, February 14th, 2026 to Sunday, February 22nd, 2026.

2. Operational plan

During the mentioned holiday schedule, TC-HICT will maintain normal operations for vessel berthing, loading/unloading cargo, and container delivery/receipt services. Other services will follow the standard holiday working schedule as regulated by the government.

For any special requests for services beyond the operations mentioned above during the holiday period, Shipping Lines, Agents, and Customers are kindly requested to notify the following deadlines:

- For New Year 2026: Before December 25th, 2025.
- For Lunar New Year: Before February 7th, 2026.

3. Storage charge waiver policy

To support our valued Shipping Lines, Agents, and Customers, in addition to the standard storage free time stipulated in current contracts or the public tariff, TC-HICT will grant an additional storage charge waiver as follows:

a. Applicable categories: Laden import containers; laden transshipment/transit containers; and laden temporary admission for re-export containers.

b. Storage free time:

- New Year 2026: 04 (four) days January 1st, 2026 to Sunday, January 4th, 2026.
- Lunar New Year: 09 (nine) days from Saturday, February 14th, 2026 to the end of Sunday, February 22nd, 2026.

Containers arriving at the terminal waiting for export must comply with the early gate-in period of no more than 07 days prior to the vessel's Estimated Time of Arrival (ETA). This period excludes the holiday schedule. (For vessels with an ETA during the holiday period, containers may be gated-in starting from December 25th, 2025 for New Year and February 7th, 2026 for Lunar New Year).

During the holiday, terminal field operations will maintain normal shifts. TC-HICT will also request the Customs Authority to arrange on-duty personnel to facilitate clearance procedures.

TC-HICT highly recommends that Shipping Lines, Agents, and Customers arrange to pick up containers during the holidays to avoid yard congestion following the festive period.
